**REPORT ON CONDUCT OF ELECTIONS TO THE BOARD OF
DIRECTORS OF THE NEW INDIA ASSURANCE EMPLOYEES' COOP
THRIFT AND CREDIT SOCIETY LTD, X 413, CHENNAI - 18.**

I, Mr.G.THIYAGARAJAN, Deputy Registrar of Cooperative Societies is working as Deputy General Manager (Internal Audit), Tamil Nadu Cooperative Marketing Federation, Chennai -18 under the control of Additional Registrar of Cooperative Societies, Chennai Region, Chennai - 18 was included in the panel of Deputy Registrar of Cooperative Societies approved by the Registrar of Cooperative Societies, Chennai, Tamil Nadu supplied to New India Assurance Employees' Cooperative Thrift & Credit Society Ltd, No. X 413. The board of directors have appointed me as the Returning Officer and convening a general body meeting for the conduct of elections to the board of directors of the society vide their resolution no.02 dated:29.02.2020 which was communicated to the Returning Officer in Managing Director letter dated 02.03.2020.

As the pandemic Covid-19 situation worsened by the second week of March 2020, the election process could not be initiated immediately. Further, the lockdown restrictions imposed by Government of India and Government of Tamil Nadu from 24.03.2020 and subsequent ban on assembly and meetings stalled the commencement of election process. In view of such restrictions on meetings and gatherings, decision on the date, time and place for convening the general body meeting for conduct of elections could not be taken. On 31.10.2020, Government of Tamil Nadu have permitted participation of maximum of 100 people in social, political, religious and cultural events from 16.11.2020. In view of relaxation of the ceiling on 31.10.2020 permitting social meetings with a participation of maximum of 100 persons, which is the quorum for the general body meeting of the society, the board of directors in their meeting held on 07.11.2020 have passed a resolution bearing

no.09 requesting the Returning Officer to conduct a general body meeting preferably in the fourth week of December 2020 and to issue notice for such meeting in the first week of December 2020.

Further, the above resolution requested the Returning Officer to elect 21 Directors of which 2 (two) have been reserved women constituency and 1 (One) has been reserved for SC/ST constituency. Also, the resolution states that the number of directors to be elected is less than reserved constituency, the rule of reservation can be applied to Directors to be elected from Chennai Region as it has 12 directors to be elected. Therefore, the Returning Officer was directed by the board of directors of the society to elect 21 (Twenty-One) directors with Regional Constituencies and after applying rule of reservation as below:

- Chennai Region - 12 Directors (Out of which 9 from General Constituency, 2 from Women Constituency and 1 from SC/ST constituency)
- Bangalore Region - 02 Directors
- Hyderabad Region - 02 Directors
- Ernakulam, Coimbatore, Madurai, Hubli and Vizag Regions - 1 Director each

Further, they also requested that rule of reservation contained in the byelaw no. on electing 2 (two) Women and 1 (One) SC/ST members as Directors could be applied to Chennai Region as the region has 12 Directors enough for the application of the rule. The Managing Director of the society has communicated the resolution to the Returning Officer with a request to conduct elections accordingly. In view of the lockdown, restrictions on movement and ceiling on the number of participants in a social meeting was substantially relaxed, I, in the capacity of the Returning Officer, issued a notice for election general body on 21.12.2020 in Chennai with a schedule of election program as under as per the provisions of MSCS Act 2002 and rules framed thereunder.

The working president and the organizing secretary, Bharathiya Vima Karamchari Sena, New India Assurance Chennai Region through a letter Ref No: BVKS/CHN RO/040 dated 16.12.2020 has requested the Returning Officer to permit the candidates from Hyderabad & Vizag regions must be allowed to file their nomination in Secundrebad branch of society, those from Bangalore and Hubli be permitted to file nominations in Bangalore branch of society in view of pandemic and risk of getting infected due to travel. The Returning Officer has given suitable reply stating that the Central Registrar has allowed the multistate cooperative societies to complete the elections to the board of directors by December 2020 in a convention way after considering the then prevailing pandemic situation in the month of September 2020 and their request could not be considered at that juncture.

This position was brought to the notice of the Central Registrar by the Returning Officer in his letter dated 18.12.2020. After considering the repeated requests made by BVKS and some members, the Returning Officer permitted supply of nomination form on an application from the prospective candidates in person or to an authorised person which shall presented to the Returning Officer in person at the appointed place, date and time as per the above act. The election general body was held on 21.12.2020 @ 10.30 am. As the

As there were only two candidates each filed nominations for Bangalore and Hyderabad regions against required number of two directors each to be elected and one each filed nominations for Ernakulam, Coimbatore, Madurai, Hubli and Vizag regions against one director each to be elected, these candidates were deemed elected as per MSCS rules and declared accordingly. In Chennai Region, following candidates contested for elections to the board of directors and therefore, polling through secret ballot was scheduled on 06.01.2021 from 10.00 am to 05.00 pm simultaneously in all the Regions to curtail time delay. The ballot consisted of three constituencies viz., General Constituency, Women Constituency and SC/ST Constituency. In order to conduct polling smoothly and simultaneously, three polling officers were appointed for each polling Centre and in all 24 polling officials for 8 polling centers were appointed and they were assigned different duties and responsibilities. As per the polling program, election related materials were transported to all the polling centers. On 06.01.2021, polling in all regions was conducted without any complaints and in a free, fair manner and through a secret ballot system. Due to pandemic and other causes the voter turnout was low. The voter turnout and percentage of polling is as below: -

Soon after the completion of polling, ballot boxes and used, unused election materials were transported back and the Returning Officer received the materials and boxes from 07.01.2021 till 08.01.2021. On 09.01.2021, the counting of ballot papers was conducted by the Returning Officer through 3 counting officials and 3 assistant counting officials were appointed for that purpose separately. Before the commencement of counting, the candidates and their authorized agents were appraised of the procedure to be followed in counting of votes and procedure on declaration of invalid votes. They were appraised that if in any constituency, the number of candidates for whom the voter affixed seal mark exceeds required number, the ballot will be treated in invalid to that constituency and rest of the constituencies consisting only required number of votes or below will be considered for results. Further, they were appraised that the decision of the Returning Officer will be final and binding upon them. After they concurred with the procedure, the counting was held in a smooth manner. As the total polled votes are 711 votes, 10 rounds of counting were planned to conduct it smoothly and quickly in view of three constituencies in the ballot. Each round consisted of 75 ballot papers for counting with three tables allotted for round counting. Each table was given 25 ballots to be counted in each round and the round level results of all the tables were consolidated. At the end of 10 rounds, the results were consolidated. The following contesting candidates secured votes as mentioned against their names mentioned below: -
