The Election of the ' Board of Directors' will be held in accordance with the Multi State Cooperative Societies Act and Rules and Bye-Laws of the Society.

The term of the Elected Directors shall be FIVE YEARS from the Date of Assumption of Charges.

If the number of contesting candidates in respect of whom valid nominations have been announced do not exceeds the number of candidates to be elected, such candidates shall be deemed to have been elected unopposed.

If the number of valid Nominations exceeds, number of Directors to be elected from each Region and/or number of Directors elected from those Reserved for women and/or SC/ST , a POLL shall be taken and the Returning Officer shall then read out the names of the contesting candidates and the election will be held by Secret Ballot in various centres as per Bye laws of the Society.
