1. Voting Procedure :

Members may cast their vote at any polling centre.

Every voter must produce either of the following at the time of voting:

1. Original / Attested Official Identity Card, or
2. Identity Certificate duly signed and attested by an Authorized Officer of The New India Assurance Company Limited, not below the rank of Administrative Officer.
(*Format enclosed with this Notice.*)

The members list was published on 15.11.2025. Only members whose names appear in the Voters List are eligible to vote. However, members who retired / dismissed / terminated / VRS-CRS / Suspension after 15.11.2025, even if their names appear in the list are not eligible to vote.

2. Number of Candidates to be Elected :

A total of 20 (Twenty) Directors are to be elected to the Board.

(17 in General Category, 2 in Women category and 1 in SC/ST category as detailed below)

Chennai Region :

- General Category – 9 candidates
- Women Category – 2 candidates
- SC/ST Category – 1 candidate

Other Regions – (General Category):

- Madurai – 1 candidate
- Coimbatore – 1 candidate
- Ernakulam – 1 candidate
- Vizag – 1 candidate
- Bangalore – 2 candidates
- Hyderabad – 2 candidates

3. Marking of Ballot Paper :

As per MSCS Rule No.19M(7) (iv) & (v) :

(iv) Separate Ballot Paper shall be prepared for (a) for Women Constituency (b) for SC / ST Constituency and (c) and for remaining Constituencies as per Bye-Laws.

(v) Generally, there shall be difference colour of paper used for each type of Constituency. For example, for Women Constituency, ballot paper can be of pink colour, for SC / ST Constituency the ballot paper can be of sky-blue colour, for General Constituency, the ballot paper can be of white colour and if there is any other Constituency, the colour of the ballot paper could be of different colour as decided by Returning Officer.

Therefore, members are requested to mark an “ X ” against the names of **not more than**

- 17 (Seventeen) in **white** colour ballot paper
- 02 (Two) in **pink** colour ballot paper and
- 01 (One) in **sky-blue** ballot paper.
- ❖ Each voter shall mark an “X” against the names of the candidates of his / her choice, using the rubber stamp provided.
- ❖ The “X” must be placed clearly within the box of the selected candidate only. Any “X” mark or ink impression that touches or overlaps another candidate’s box will render the ballot paper invalid.
- ❖ If a voter casts more votes than the permitted number in any category or in any constituency **as mentioned above in Sl.No.2**, the ballot will be treated as invalid for that specific category or constituency only, while the votes in the other categories / constituencies will remain valid.
- ❖ Ballot papers that are spoiled, mutilated, damaged, or improperly marked (including smudged ink, unclear impressions, or ink overlapping another candidate’s box) will be treated as invalid.

4. Counting of Votes (Revised Schedule):

As per the instructions of the Cooperative Election Authority, New Delhi and orders of the Returning Officer Dated: 26.05.2026

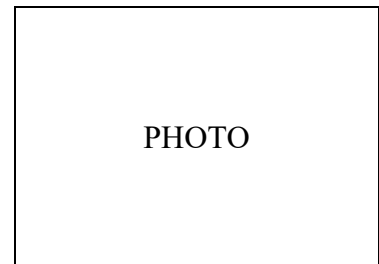
